

Managers, Timekeepers and HR Practitioners can approve the time entered by employees. You have the option to approve, deny, or send back time entered by employees.

## APPROVE TIME ENTERED

To view a Time Entry approval request:

1. Navigate to your **Inbox**.
2. Click the **Time Entry** task for the respective employee.
3. After reviewing the employee's time, click **Approve** at the bottom of the page to approve the time entered.



### Note:

- **Send Back** - used to send an employee's entered time back to them to modify.
- **Deny** button - used to deny an employee's entered time. If you send or deny and employee's time you will need to enter a comment an appropriate comment and detail for sending back or denying the time entered.
- **Close** - allows you to not take any action on the time entered.

4. If approved, click the **Detail and Process** arrow to view the employee's time entry summary.
5. Click **Done**.
